MOTION FOR CORRECTION

COMES NOW Craw-Kan Telephone Cooperative ("Craw-Kan") and for its Motion for Correction states to the Commission as follows:

- 1. On January 17, 2003, Craw-Kan filed its *Application for Approval of a Traffic Termination Agreement*.
- 2. On April 4, 2003, the Commission issued an *Order Approving Interconnection Agreement* in this case. The Commission's *Order* refers to the agreement between Craw-Kan and Verizon Wireless as an "Interconnection" Agreement rather than a "Traffic Termination" Agreement.
- 3. Craw-Kan requests that the Commission issue a corrected *Order* with the following changes:
 - (A) The title changed to Order Approving <u>Traffic Termination</u> Agreement.
 - (B) The first sentence of the *Order* revised to read as follows: "This order approves the <u>Traffic Termination</u> Agreement executed by the parties and filed by Craw-Kan Telephone Company."
 - (C) The second sentence of the *Order* revised to read as follows: "On January 17, 2003, Craw-Kan filed an application with the Commission for approval of a <u>Traffic Termination</u> Agreement with Verizon

Wireless, LLC, St. Joseph CellTelco, and Cellco Partnership (all d/b/a Verizon Wireless)."

(D) That the first ordered paragraph on page five of the *Order* be revised to read as follows: "1. That the <u>Traffic Termination</u> Agreement between Craw-Kan Telephone Cooperative, Inc., and Verizon Wireless, LLC, St. Joseph CellTelco, and Cellco Partnership (all d/b/a Verizon Wireless) filed on January 17, 2003, is approved."

WHEREFORE, Craw-Kan respectfully requests the Commission to issue an Order that makes the corrections listed above and grants such other relief as is reasonable in the circumstances.
