On March 12, 2008, in File No. KA-2008-0272, the Commission, pursuant to Section 67.2679, RSMo 2000 (Cum. Supp. 2007), granted McDonald County Multi-Media, L.L.C. (the Company) authority to provide video service in the franchise areas of the political subdivisions of McDonald County, the City of Anderson, and the Village of Jane.

On March 1, 2022, the Company filed notice with the Commission that it has ceased to provide video service, has no video service customers, and requests cancellation of its video service authorization.

Under Section 67.2685, RSMo 2016, the Company's video service authorization shall expire upon notice to the Commission that it will cease to provide video service under such authorization.

THE COMMISSION ORDERS THAT:

- 1. The Commission acknowledges receipt of notice by McDonald County Multi-Media, L.L.C. that it has ceased to provide video service authorized by the Commission in File No. KA-2008-0272. The authorization expires by operation of law and no further action by the Commission is required.

 - 3. This file shall be closed on March 12, 2022.
