APPLICATION FOR VIDEO SERVICE AUTHORITY

COMES NOW Kingdom Telephone Company (“Applicant” or “Kingdom”),
pursuant to Section 67.2679.7 RSMo. and Missouri Public Service Commission
 (“Commission”) Rule 4 CSR 240-2.060, and states as follows:

1. Applicant is a Missouri corporation with its principal Missouri office
located at 211 South Main, Auxvasse, MO, 65231. A certificate of good standing was
filed in Case No. TC-2011-0404 and is incorporated by reference.

7. Kingdom is legally, financially, and technically qualified to provide video service.



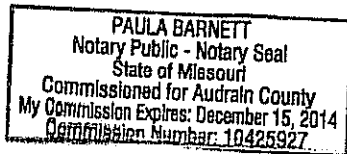
