ORDER TO PROVIDE NOTICE TO CITIES AND COUNTIES OF RATE INCREASE

Issue Date: July 13, 2018 Effective Date: July 13, 2018

Section 393.275.1, RSMo 2016, requires the Commission to notify the governing body of each city or county imposing a business license tax on gross receipts of any gas corporation of any approved rate increase for that gas corporation that exceeds seven percent. Further, the statute requires the Commission to:

include with such notice to any city or county the percentage increase approved for the utility, together with an estimate of the annual increase in gross receipts resulting from the tariff increase on customers residing in that city or county.

Section 393.275.2, RSMo 2016, requires the taxing authority to reduce its tax rate to reduce the amount of revenue collected under the tax, unless it chooses to maintain its tax rate.

On June 6, 2018, the Commission approved a stipulation and agreement that allowed Liberty Utilities to increase the company's annual revenues from its provision of natural gas service by more than seven percent in its WEMO district. Liberty Utilities' tariff sheets to implement the allowed rate increase went into effect on July 1.

On July 12, as required by the statute and Commission regulations, Liberty Utilities submitted a list of the cities and counties within its WEMO district that impose a business license tax on its gross receipts, along with an estimate of the annual increase in gross receipts resulting from the rate increase on customers residing in that city or county. That list and revenue increase estimate is attached to this order.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall mail a copy of this order to each city or county identified by Liberty Utilities.
 - 2. This order shall be effective when issued.
