Dear Secretary Dale:

The Commission Staff requests the issuance of the attached Subpoena for Witness.

On May 17, 2007, Spectra Communications Group, LLC d/b/a CenturyTel (Spectra) filed its verified Application for Competitive Classification pursuant to Section 392.245.5, RSMo Cum. Supp. 2005. Spectra claims that Charter Fiberlink-Missouri, LLC, provides local voice service to business customers or to residential customers in certain exchanges. The Commission directed the Staff to investigate this matter.

On May 21, the Staff sent an e-mail to its regulatory contact at Charter, asking Charter to state in an affidavit whether it is currently providing service to at least two residential customers within one listed exchange and to provide customer and line counts for that exchange. On May 22, Charter responded with a request that the Staff's request be sent under a cover letter addressed to Carrie Cox, Charter's VP Legal and Regulatory Affairs. On May 23, Staff counsel left a voice mail for Ms. Cox, requesting a call back on this matter. On May 24, the Staff mailed a letter requesting the information. The letter was delivered on May 25. Staff counsel left a second voice mail for Ms. Cox on May 30. Charter has not responded to either voice mail or to the Staff's letter.

Because Charter has failed and refused to provide the requested information, the Staff requests the Commission to issue a subpoena requiring the attendance of Ms. Cox at the hearing in this matter.

Commission Rule 4 CSR 240-2.100(2) provides that except for a showing of good cause, a subpoena should not be issued fewer than 20 days before a hearing. The fact that this case is on a 30-day track provides good cause for the issuance of a subpoena fewer than 20 days before the hearing.
