**ORDER APPROVING TARIFF**

Issue Date: October 13, 2010

Effective Date: October 23, 2010

On September 27, 2010, AT&T Communications and AT&T Missouri (AT&T) filed a motion asking the Commission to suspend and investigate a tariff filed by Orchard Farm Telephone Company, a TDS Telecom Company. AT&T's motion explained that Orchard Farm's tariff would modify existing intrastate switched access tariff provisions. The AT&T companies did not oppose the goal of revising the tariff provisions, but contended the tariff proposed by Orchard Farm was vague, ambiguous, and should be clarified before it was allowed to go into effect. The Commission's Staff supported AT&T's motion to suspend the tariff.

In response to AT&T's motion, the Commission suspended Orchard Farm's tariff until November 30, and directed Orchard Farm and the Commission's Staff to respond to AT&T's motion to suspend by October 5. Orchard Farm responded by filing a revised tariff on October 1. Staff filed a recommendation on October 4 advising the Commission that Orchard Farm's revised tariff addresses the concerns that Staff had with the original tariff. Staff recommended that the Commission approve Orchard Farm's revised tariff. On October 5, AT&T filed a notice indicating that it also is satisfied with Orchard Farm's revised tariff and no longer objects to that tariff.

Based on Staff's recommendation and AT&T's withdrawal of its objection to Orchard Farm's tariff, the Commission will approve that tariff.

**THE COMMISSION ORDERS THAT:**

1. The tariff submitted under Tariff File No. JI-2011-0107, on September 1, 2010, by Orchard Farm Telephone Company, previously suspended from October 1, 2010, to November 30, 2010, as revised on October 1, 2010, is approved.
