MOTION TO MAKE TARIFFS EFFECTIVE ON LESS THAN THIRTY DAYS NOTICE

Comes now Cass County Telephone Company ("Cass County") and for its Motion to

Make Tariffs Effective on Less Than Thirty Days Notice ("Motion") states to the Missouri Public

Service Commission ("Commission") as follows:

- 1. On April 29, 2004, the Commission issued an Order Approving Unanimous Stipulation and Agreement in which it approved a stipulation resolving Staff's earning investigation and reducing Cass County's gross intrastate revenues by approximately \$319,998 per year. The stipulation calls for a \$154,948 reduction in Tier 4 and Tier 5 MCA rates, a \$154,948 reduction in terminating carrier common line rates and a \$10,102 rate reduction for enhanced E911 service. This Order will become effective May 9, 2004.
- 2. Cass County previously submitted proposed tariffs to effect these reductions to Staff for its review. On this same date, Cass County is filing these tariffs with a thirty (30) day effective date as required by 4 CSR 240-3.545(27). Cass County requests that the Commission make these tariffs effective on less than thirty (30) days, however, so that the effective date will coincide with Cass County's billing cycle and its customers will be able to receive the benefits of the rate reduction at an earlier date. For that reason, Cass County requests that the tariffs be made effective on May 16, 2004.

Wherefore, Cass County respectfully requests that the Commission approve its Motion to Make Tariffs Effective on Less Than Thirty Days Notice and for any other relief appropriate in the circumstances.
