JOINT MOTION FOR EXTENSION OF TIME TO FILE

COME NOW The Empire District Electric Company ("Empire" or "Company"), the Staff of the Missouri Public Service Commission ("Staff"), and the Office of the Public Counsel, and for their Joint Motion for Extension of Time to File, respectfully state as follows:

- 1. On November 3, 2000, Empire filed with the Missouri Public Service Commission ("Commission") tariff sheets designed to increase its rates for electric service to the Company's customers in Missouri.
- 2. On January 4, 2001, the Commission issued an order that, among other things, adopted a procedural schedule containing a requirement that the parties develop and agree on a list of issues to be determined by the Commission in this case, along with a list of witnesses and the order of cross examination. The information was to be filed by May 10, 2001. The evidentiary hearing is scheduled for May 29 through June 8, 2001.
- 3. Since the April 16-19 prehearing conference, the parties have been actively and intensively engaged in efforts to develop a stipulation and agreement pertaining to some major issues in the case, including fuel and purchased power expense. It is anticipated that a stipulation and agreement will be filed within a matter of a couple of days.

- 4. In light of the amount of effort required to develop the stipulation and agreement, and of the fact that the agreement itself is expected to have a major impact on the list of issues and associated witness information ultimately to be filed, the undersigned parties agree that it is advisable to delay, until May 14, 2001, the filing of the list of issues, list of witnesses and order of cross-examination.
- 4. Praxair, Inc., the only other party to this case, states, by and through its counsel, that it does not oppose this motion.

WHEREFORE, the undersigned parties respectfully request that the Commission extend until May 14, 2001, the deadline for filing the List of Issues, List of Witnesses and Order of Cross-Examination for the evidentiary hearing in this case.
