**JOINT MOTION FOR SUSPENSION OF

**COME NOW** the Staff of the Missouri Public Service Commission (“Staff”), the Office of Public Counsel (“OPC”), Kansas City Power & Light Company (“KCP&L”), KCP&L Greater Missouri Operations Company (“GMO”), Southwest Power Pool, Inc. (“SPP”), Dogwood Energy, LLC (“Dogwood”) and The Empire District Electric Company (“Empire”) (collectively, the “Parties”) and hereby file this *Joint Motion for Suspension of Procedural Schedule and Hearings*.

1. A Stipulation and Agreement (“Stipulation”) was filed in both of the above-referenced files on May 16, 2013. The Stipulations were signed by all Parties except Empire. Empire’s counsel has indicated to the Parties that Empire will not oppose the Stipulations.

2. The Parties believe that Surrebuttal Testimony scheduled for May 16, 2013, the settlement conference scheduled for May 20, 2013, and the evidentiary hearing scheduled for June 5-7, 2013 are not necessary due to the filing of the Stipulations. Accordingly, the Parties move the Commission to suspend the procedural schedule and hearings.
