JOINT PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission (Staff) by
and through one of its attorneys, and states the following:

1. On or about July 14, 2000, the Commission ordered the Parties to file
a Joint Procedural Schedule that included a date for a hearing to occur on or before September
15, 2000, as is required by §247.172.2 RSMo 1994.
2. Staff has contacted the representative for the Applicants and the Office of Public
Counsel (OPC) to arrange mutually acceptable dates for the proposed procedural schedule.
3. In addition, Staff represents to the Commission that it is very likely that the
Parties can complete and execute a Stipulation and Agreement for presentation to the
Commission by no later than August 24th, 2000.
4. OPC has offered no objections to either the proposed date for the filing of a
Stipulation and Agreement, or to the proposed hearing date in this matter.

5. The Staff and the Applicants have agreed that dates for the proposed Procedural Schedule are as follows:

Parties File Stipulation and Agreement

August 24, 2000

Evidentiary Hearing

September 7, 2000

THEREFORE, based on the foregoing, the Staff respectfully requests that the Commission issue an Order establishing a Procedural Schedule as set forth in Paragraph 5 above.
