JOINT PROPOSED PROCEDURAL SCHEDULE

COMES NOW Liberty Energy (Midstates) Corp. d/b/a Liberty Utilities (“Liberty Utilities”), the Staff of the Missouri Public Service Commission (“Staff”), and the Office of the Public Counsel (“OPC”) (collectively the “Parties”), pursuant to the Commission’s *Order Scheduling Evidentiary Hearing and Directing Filing of Joint Proposed Procedural Schedule* (“Order”) entered in this matter on September 10, 2013, and respectfully state as follows:

1. The Commission’s Order directs the parties to file a joint proposed procedural schedule no later than September 13, 2013. This filing complies with the Commission’s Order.
2. The Parties jointly propose the following procedural schedule to be adopted by the Commission:

Conference call – to discuss List of Issues	September 17, 2013
List of Issues, List of Witnesses, Order of Cross-Examination, and Order of Opening Statements	September 19, 2013
Simultaneous Testimony or Updated Report – All Parties	September 20, 2013
Position Statements	September 24, 2013
Evidentiary Hearing	September 26-27, 2013
Briefs (expedited transcript required)	October 8, 2013

3. The Parties suggest that this proposed schedule will permit the Commissioners to conduct post-hearing discussions on October 9, 2013, and issue an order on October 16, 2013, to be effective October 26, 2013. As noted in the Commission's *Order Suspending Tariff* issued July 8, 2013, the statutory 120-day deadline for Commission action and tariff suspension period fall on October 30, 2013.

WHEREFORE, the Parties submit their Joint Proposed Procedural Schedule as directed by the Commission in its Order for its consideration and adoption.
