# JOINT STIPULATION SEEKING STAY OF MATTER IN LIGHT OF SETTLEMENT BETWEEN COMPLAINANT JACOR CONTRACTING, INC. AND NUVOX COMMUNICATIONS OF MISSOURI, INC.

("JACOR") and Respondent NuVox Communications of Missouri, Inc., ("NuVox") offer this joint stipulation to seek a stay of all proceedings in the case while JACOR and NuVox document and otherwise put into effect an agreed compromise of JACOR's claims. In support of this request, JACOR and NuVox state as follows:

- 1. At this point, work on JACOR's facilities are complete and those efforts have resulted in providing JACOR uninterrupted service to date.
- 2. JACOR and NuVox have reached an agreement relative to the resolution of JACOR's claims. As a result of this settlement, JACOR will be dismissing with prejudice its claims against NuVox and Southwestern Bell Telephone Company d/b/a/ AT&T Missouri ("AT&T Missouri").

- 3. JACOR and NuVox ask that the Commission stay all proceedings in this matter for 30 days, to allow JACOR and NuVox sufficient time to document and otherwise effectuate the settlement.
- 4. Such stay is in the best interests of all involved as it conserves the resources of all parties while the settlement is put in place.
