**UNANIMOUS NOTICE OF TESTIMONIAL ARRANGEMENTS**

3. As an accommodation to the work and care-taking schedules and travel complications of non-party witnesses, and to promote efficient presentation of testimony, witnesses Jonathan Guelich, Brian Johnson and Marilyn Jean Kessler will testify by telephone.

4. In recognition of the straight-forward nature of his testimony, witness Fred Baras' testimony will be submitted on written testimony only. The parties have agreed that they will not have further questions for him. USW Local 11-6 will make him available by telephone to answer questions from the bench, if so requested.

Wherefore, the parties unanimously submit their intended testimonial arrangements in this matter and ask that the Commission notify them if any of these arrangements are unacceptable.
