STATUS REPORT

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Company”), and in response to the Commission’s May 29, 2013 *Order Directing Status Report*, states as follows:

1. On April 15, 2013, the Company filed its Response to Commission Order and stated therein that the Company (and Laclede Gas Company) had reached a settlement in principle with MoGas Pipeline, LLC (“MoGas”) that the Company believed would resolve the above-captioned ACA cases. At that time the Company believed it

would be in a position to finalize the settlement and to file the settlement agreement by mid-May, 2013.

2. On May 28, 2013, the Company, Laclede Gas Company and MoGas executed a settlement agreement resolving all issues relating to the MoGas overcharges that have been the subject of several litigated cases, including cases in front of the Commission, multiple circuit courts and the appellate courts in Missouri. That settlement agreement is contingent upon certain approvals by this Commission.

3. The Company, together with Laclede Gas Company, is in the process of drafting a joint motion seeking the Commission approvals contemplated by the settlement agreement, and expect to file that motion (to which the settlement agreement will be attached) in the next several days.

WHEREFORE, the Company files the foregoing Status Report as required by the Commission's May 29, 2013 *Order Directing Status Report*.
