ORDER GRANTING PROVISIONAL EXTENSION OF ACTIVATION PERIOD FOR NUMBERING RESOURCES

On November 17, 2006 Pac-West Telecom, Inc., filed a Petition for an Extension of the Activation Period for Numbering Resources and Motion for Expedited Consideration. In its petition, Pac-West requests an order from the Commission within ten days of its filing granting it a 90-day extension of the activation periods at issue.

Pac-West states that the extension is required due to "unanticipated delays in interconnecting with AT&T Missouri." Pac-West further states that if it fails to get an order granting its request from the Commission within ten (10) days, it is in jeopardy of losing the telephone numbering resources at issue in Missouri, which would greatly harm Pac-West's ability to compete and would seriously harm its customers in the state. Pac-West further states that it filed its pleading as soon as it became aware of the jeopardy of losing the numbering. Pac-West attached documentation setting out the original activation dates and the proposed activation dates.

Upon review of Pac-West's documentation, the Commission discerned that Pac-West's request for an order by November 27, 2006, would not protect the numbering resources at issue. The original activation dates for several of those numbering blocks are November 22, 2006. Accordingly, to protect those numbering blocks Pac-West requires an order extending the original activation dates effective no later than November 22, 2006. Due to the late filing of Pac-West's request, there is not time to afford interested parties sufficient notice and timely grant Pac-West the relief it requests.

The Commission will grant Pac-West a 14-day extension from the original activation dates of the numbering blocks in question. This will allow potentially interested parties an opportunity to object to Pac-West's request. If no parties object to Pac-West's request, the Commission will authorize the assigned regulatory law judge to directly issue an order granting Pac-West an additional extension to the originally requested 90 days.

IT IS ORDERED THAT:

1. Pac-West Telecom, Inc. is granted an extension of 14 days from the original activation date for the numbering blocks listed in the attachment to its Petition for Commission Approval of an Extension of Time to Utilize Numbering Resources filed on November 17, 2006.

2. Any party wishing to intervene in this case or object to Pac-West Telecom, Inc.'s Petition for Commission Approval of an Extension of Time to Utilize Numbering Resources shall do so no later than December 1, 2006.

3. If no party objects to Pac-West Telecom, Inc.'s, Petition for Commission Approval of an Extension of Time to Utilize Numbering Resources on or before December 1, 2006, the regulatory law judge assigned to this case may directly issue an

order granting Pac-West Telecom, Inc., an extension up to the 90 days originally requested.

4. This order shall become effective on November 22, 2006.
