


**MOTION FOR LEAVE TO FILE  
ANNUAL REPORT OUT OF TIME**

Comes now Lockheed Martin Global Telecommunications Services, Inc. ("LMGTSI" or the "Company"), by and through counsel, and pursuant to 4 CSR 240-3.540(4) respectfully requests the Commission and its Secretary for leave to file its 2002 Annual Report to the Commission as an Interexchange Carrier (the Annual Report) out of time. In support thereof, LMGTSI states the following to the Commission:

1. LMGTSI was certificated by this Commission in July 2002 in Case No. TA-2002-286. The Company is current with all annual assessments. However, due to an unfortunate oversight, LMGTSI failed to timely file its 2002 IXC annual report.
2. Attached to this motion is the original of LMGTSI's 2002 IXC annual report.
3. Permitting LMGTSI to late file its annual report out of time would not be detrimental to the public interest. Its delay in filing was not intentional, and was not the result of wilful disobedience to a Commission rule. Granting leave to late file the annual report would be just and proper under the circumstances.

WHEREFORE, LMGTSI respectfully requests the Commission to allow it to file its 2002 IXC annual report out of time and for such other orders that the Commission deems meet and just under the circumstances.


