ORDER GRANTING FURTHER EXTENSION OF ACTIVATION PERIOD FOR NUMBERING RESOURCES AND DIRECTING FILINGS

Issue Date: December 4, 2006 Effective Date: December 6, 2006

On November 17, 2006 Pac-West Telecom, Inc., filed a Petition for an Extension of the Activation Period for Numbering Resources and Motion for Expedited Consideration. In its petition, Pac-West requested an order from the Commission granting it a 90-day extension of the activation periods at issue.

To protect those numbering blocks Pac-West required an order extending the original activation dates effective no later than November 22, 2006. Because of the press of time, the Commission granted Pac-West a 14-day extension from the original activation dates of the numbering blocks in question and set a deadline of December 1, 2006, for any interested party to object to Pac-West's request. No objections were received.

On November 30, 2006, the Staff of the Commission responded to the Commission's November 21st Order. Staff stated that it did not oppose the Commission granting Pac-West the requested extensions, but recommended that the Commission order Pac-West to:

- file a pleading in this case in the event of further delay or deviation from the extension.
- file a status report or letter in this case when the numbering resources subject to the Commission's order are activated.

The Commission finds Staff's recommendations to be reasonable. The Commission will grant Pac-West an additional extension of 76 days and will adopt the recommendations proposed by Staff.

IT IS ORDERED THAT:

- 1. Pac-West Telecom, Inc. is granted an additional extension of 76 days in the activation dates for the numbering blocks listed in the attachment to its Petition for Commission Approval of an Extension of Time to Utilize Numbering Resources filed on November 17, 2006. Combined with the initial 14 day extension granted in the Commission's November 21st Order, this effectively grants Pac-West Telecom, Inc., the requested 90-day extension of the original activation dates for the numbering blocks at issue.
- 2. Pac-West Telecom, Inc., shall file a pleading in this case in the event of further delay or deviation from the extension granted by this order.
- 3. Pac-West Telecom, Inc., will file a status report or letter in this case when the numbering resources at issue are activated.
 - 4. This order shall become effective on December 6, 2006.
