**COMPLAINANT'S RESPONSE TO THE NEW REGULATORY
JUDGES ORDER SETTING DEADLINE FOR A RESPONSE TO THE
REPORT AND ORDER**

Comes now, Mr. Craig Mershon in a response to the new Regulatory Judges order setting a deadline for Mr. Mershon to respond to the Report and Order under the former Regulatory Judge Mr. Daniel Jordan. Mr. Mershon made a call to Mr. Morris Woodruff, Secretary telling him that his computer crashed Mr. Woodruff promised no action would be taken on his case until he heard from Mr. Mershon and nothing would be held against Mr. Mershon until he heard from him. What has happened proves Mr. Woodruff did not tell Mr. Mershon the truth.

Mr. Mershon thought Mr. Woodruff cared about the case and him. He found out otherwise when he received in the mail a copy of a Report and Order with no date that it was to take place. At the time that Mr. Mershon received the first Report and Order his computer had not been replaced. As of now Mr. Mershon is still trying to learn how to

operate the new computer because there are different mechanisms doing different functions on the new computer. Mr. Mershon is unaware of how to operate all of them at this time.

Mr. Mershon also has a physical as well as a visual disability. It takes him a little bit longer because of his limited vision and limited mobility to accomplish goals, but they are eventually accomplished. Right now Mr. Mershon has five parts to his response to the Report and Order submitted by Mr. Jordan. Mr. Mershon thinks Mr. Jordan deliberately with malice tried to hurt him along with Ms. Sarah Giboney from Smith and Lewis LLP and Mr. Jeffrey Keevil, Attorney from the Missouri Public Service Commission.

Mr. Mershon is in the process of filing a Preliminary Motion in Response to the Report and Order from Mr. Jordan. This document will be limited and will be facsimiled to Mr. Woodruff. Right now Mr. Merton's typist will be on vacation for the Memorial Day holidays and will not return until May 27, 2014. At that time Mr. Mershon hopes to have a letter sent to Mr. Woodruff and most of the preliminary document completed.

Mr. Mershon used information that was given to him by Mr. Woodruff. He does not have access to the Rules and Regulations that many of the people in the case have access to because he was denied the right to get information even after he filed a motion to get documents. So any motions that were filed earlier were filed with the understanding the information given to him was by Mr. Woodruff.

Mr. Wess Henderson, Director of Administration and Regulatory Policy promised Mr. Mershon he would get some information for him as possible, but Mr. Henderson backed out claiming that he was instructed that talking to Mr. Mershon was inappropriate. According to Mr. Henderson Mr. Mershon was told numerous times to

find an attorney. Mr. Mershon informed Mr. Henderson and Mr. Joshua Harden he was unable to pay for legal counsel many times. Mr. Mershon is going to file a case against some of the people at the Missouri Public Service Commission including Mr. Jordan because he has been treated unfairly by many of the staff at the Commission. This process will take place if the unfairness and crew treatment by the Commission staff continues.

Mr. Mershon has also filed a Motion to Dismiss the Report and Order submitted by Mr. Jordan because he believes it is very discriminatory and unfair. It is not truthful because the things mentioned in it are distorted to favor Mr. Jordan and the Commission. Mr. Mershon does want to thank the new Regulatory Judge because she has informed Ameren Missouri not to disconnect Mr. Mershon even though he has paid this month's utility bill which was \$79.00. Mr. Mershon paid \$70.00.

Under law Mr. Mershon is entitled to accommodations for various things he's decides to undertake. The Americans with Disabilities Act 1990 outlines the conditions that fall under Mr. Mershon circumstances. Mr. Mershon also thanks the Report and Order were untimely because at the time it was submitted Mr. Mershon did not have a working computer to draft a response to it. Mr. Mershon will need extra time to complete both of the Reports and Orders. At this time he is working on the preliminary motion.
