**RESPONSE TO ORDER DIRECTING FILING**

1. As part of its filing on December 28, 2007, the Office of the Public Counsel ("OPC") moved to declassify the Deposition of Michael J. Chesser, Chairman of the Board of Directors and Chief Executive Officer of Great Plains Energy, and the Deposition of William H. Downey, President and Chief Operating Officer of Great Plains Energy, as well as President and Chief Executive Officer of KCPL. Both depositions were taken on November 28, 2007 in this proceeding.
