ORDER SETTING TIME FOR COMPANY RESPONSE
TO ACCIDENT REPORT

This case was established for the purpose of receiving the Staff
Accident Report pertaining to the investigation of a natural gas explosion in a
single-story commercial building at 2208 Vine Street in Kansas City, Missouri, on
January 12, 1983. The building at 2208 Vine Street receives natural gas service
provided by The Gas Service Company.


The Engineering Staff of the Commission filed its Staff Accident Report
in this case on May 26, 1983. The Commission determines that The Gas Service
Company should be provided until July 8, 1983, for the filing of its response to
the Staff Accident Report. After the Company's response is filed, the Commission
will determine whether any additional proceedings are necessary in this case.

ized to file its response to the Staff Accident Report filed in this case on
May 26, 1983, on or before July 8, 1983.


