- 3. To date, the Training Advisory Group has not been created and other entities have not been provided an opportunity to indicate interest in participation in the Training Advisory Group.
- 4. To date, no date and time has been set for the initial meeting of the Training Advisory Group.

WHEREFORE, the Staff and the Unions respectfully request that the Commission issue notice to all parties of the creation of the Training Advisory Group, setting a deadline for other entities to indicate interest in participating in the Training Advisory Group, and establishing a date and time for the initial meeting of the Training Advisory Group.
