Once again immediately after a water main repair water stops flowing through my basement.

Would Staff like to come and inspect the basement to verify the latest water main repair? Or maybe MAWC would like to return with the basement Expert who knew exactly why the basement was leaking last time he was here and explain why once again days after a water main repair water has stopped flowing through my basement? The sump pump in my basement is operating about every two or three hours at this point, we have had plenty of rain lately.

Once again after complaining for many months the leaking water main finally bursts and is repaired. For MAWC to deny there is a problem for months and years and allow water to damage property is extremely negligent.

This latest repair leaves water running out of the ground in at least three places near my home. DNR did testing in two of these places today July 22, 2009 and found chlorine and fluoride. I hope to have test results in letter form buy Friday.

The above two pictures were taken when I inspected this meeter housing at the First Church Of God at Coal Bank and Larimore On July 13, 2009 There was about a foot of water in this meeter housing indicating the level of the ground water in the area at approximately three feet below ground level.



The above two pictures were taken when I reinspected this meeter housing at the First Church Of God 11532 Larimore Rd. On July 20, 2009 and found the water level had subsided. I suspected that a water main repair had been made near by reducing the level of the ground water table.

And is just across the street from where I have been complaining about water running out of the ground for many months.
