**APPLICATION TO EXTEND TIME FOR FILING OF  
ANNUAL REPORT**

COMES NOW Lake Region Water & Sewer Company (the "Company"), and, in accordance with Missouri Public Service Commission ("Commission") Rules 4 CSR 240-2.060, 4 CSR 240-3.335 and 4 CSR 240-3.640, requests an extension to prepare and file its Annual Report ("Annual Report"). In support thereof, the Company states as follows:


1. The Company is a Missouri corporation with its principal office and place of business at 62 Bittersweet Road, Lake Ozark, Missouri, 65049; 573-365-6792. The Company is a Missouri corporation in good standing. A Certificate of Good Standing from the Office of the Missouri Secretary of State is attached hereto as **Appendix A**.
2. The Company has no pending action or final unsatisfied judgment or decision against it from any state or federal agency or court involving customer service or rates and having occurred within three years of the date hereof. The Company has no overdue Commission annual reports or assessment fees. The Company's activities are not the primary focus of any case pending before the Commission.
3. The Company is a "public utility" as that term is defined in RSMo. §386.020, and is subject to the jurisdiction and supervision of the Commission as provided by law.
4. The Company's Annual Report is due on or before April 15, 2005.
5. In order to properly prepare an accurate Annual Report, an audit of the Company's financial statements should be completed.
6. The Company came under common management with Ozark Shores Water Company and The Meadows Water Company in October of 2004. Prior to this time, the Company's financial statements had not been audited for several years. Management continues to

look for relevant information and files for its auditors. The Company believes that its auditors will not be in a position to complete the audit of the Company's 2004 financial statements for several months.

7. The Company believes that the audit can be completed and its Annual Report filed with the Commission by August 31, 2005.

WHEREFORE, for the good cause shown above, Lake Region Water & Sewer Company requests the Commission to grant its Application to Extend Time for Filing of Annual Report, and allow the Company until August 31, 2005, to file its Annual Report.




