I, Randal S. Milch, a natural person, do hereby swear and affirm that I am an officer of MCI Communications Services, Inc. d/b/a Verizon Business Services ("Applicant"), and that the following statements are true and correct to the best of my knowledge and belief:

(1) The location of the principal place of business and the names of the principal executive officers of the Applicant:

One Verizon Way Basking Ridge, New Jersey 07920 John F. Killian – President and CEO Francis J. Shammo – Senior Vice President and CFO Randal S. Milch – Senior Vice President, General Counsel and Secretary.

(2) Each exchange, in whole or in part, of a local exchange company in which the Applicant proposes to provide interconnected voice over Internet protocol service:

Applicant seeks authority to offer interconnected voice over internet protocol service in all Missouri exchanges.

(3) The Applicant is legally, financially, and technically qualified to provide interconnected voice over Internet protocol services;

(4) The Applicant is ready, willing, able, and will comply with all applicable state and federal laws and regulations imposed upon providers of interconnected voice over Internet protocol services;

- (c) Local enhanced 911;
- (d) Any applicable license tax;

(6) The Applicant will remit the annual assessment imposed by the Commission under §386.370 RSMo;

(7) The Applicant will file, either directly or indirectly through an affiliated competitive local exchange carrier, with the Commission an annual report at a time and covering the yearly period fixed by the Commission;

(8) The Applicant has established a process for handling inquiries from customers concerning billing issues, service issues, and other consumer-related complaints. Consumer complaints may be directed to 1-800-264-1000; and,

(9) The Applicant's interconnected voice over Internet protocol service

meets the following criteria:

(a) Enables real-time, two-way voice communications;

(b) Requires a broadband connection from the user's location;

(c) Requires Internet protocol-compatible customer premises equipment; and

(d) Permits users generally to receive calls that originate on the public switched telephone network and to terminate calls to the public switched telephone network.
