STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through its attorney, and submits to the Missouri Public Service Commission ("Commission") its Staff Recommendation and recommends the Commission approve Laclede's tariffs to modify its Infrastructure System Replacement Surcharge ("ISRS"), and in support of that recommendation states as follows:

1. On December 29, 2010, Laclede Gas Company ("Laclede") filed replacement tariff sheets having ISRS rates consistent with the Staff's Recommendation filed

December 28, 2010.

2. On December 28, 2010, the Commission directed Laclede to file its response to the Staff Recommendation by January 3, 2011.

3. On December 29, 2010, Laclede filed its Response accepting Staff's calculation for pre-tax revenues, and also Staff's recommended ISRS rates. Laclede contemporaneously filed a substitute tariff sheet to comply with Staff's Recommendation.

4. On December 29, 2010 the Commission directed Staff to notify the Commission whether Laclede's substitute tariff sheet complied with Staff's Recommendation.

3. As further detailed in Appendix A, Staff has reviewed Laclede's tariff sheet and has found it to be in compliance with the Staff's December 28, 2010 Recommendation in this case.

4. Additionally, Staff raises no objection to the request for an expedited effective date of January 7, 2011. Therefore, Staff recommends that the following tariff sheet, as filed on December 29, 2010, be allowed to go into effect on January 7, 2011, or as soon thereafter as practical, as requested by Laclede.

WHEREFORE, for the foregoing reasons, Staff respectfully requests that the Commission accept Staff's recommendations in this case, approve Laclede's tariff as submitted and issue its Order approving the tariff as soon as practical in accord with Staff's recommendations.
