WITHDRAWAL OF APPLICATION

COMES NOW Kansas City Power & Light Company ("KCP&L") and, pursuant to 4CSR 240-2.116(1), states as follows:

1) While KCP&L continues to believe that the Commission does not have jurisdiction in this matter, KCP&L appreciates the Commission's efforts to process the pending application on an expedited basis.

2) KCP&L also appreciates Staff's and Public Counsel's efforts in filing their recommendation.

3) As indicated in KCP&L's July 9 pleading, due to the regulatory uncertainties surrounding the Commission's assertion of jurisdiction in this matter, negotiation with the potential buyer has come to a standstill.

4) The sale of the 32 wind turbine generators ("WTGs") was part of a transaction where the buyer would use those WTGs and purchase others for a 100 MW project.

5) As an alternative to its original plan, KCP&L has now issued an RFP for construction and ownership of a 48 MW wind turbine project, using the 32 WTGs that KCP&L had contemplated transferring to a wind developer as part of a Power Purchase Agreement. KCP&L is currently evaluating the RFP responses. Under this alternative "construct and own" plan, it is important to KCP&L that the 32 WTGs will be put into rate base in a timely manner, provided they are in-service by the end of the true-up period in its current rate proceeding (ER-2010-0355). Such regulatory treatment is crucial for KCP&L to go forward with this alternate plan.

6) Because KCP&L no longer contemplates transferring the turbines to a wind developer as part of a Purchased Power Agreement, KCP&L withdraws its application in this docket.

WHEREFORE, for the above and foregoing reasons, KCP&L hereby withdraws its application in this docket.
