AG PROCESSING INC'S REPLY TO EMPIRE DISTRICT RESPONSE

Empire District's Response to AGP's objection to Empire's intervention in this case adds nothing new and confirms that Empire's asserted "interest" is no more than that of the general public, indeed, that of an interloper and meddler. Empire identifies only one issue -- depreciation -- in which it claims an interest. This is like arguing that it has an "interest" because it also uses a double entry accrual accounting system and wants to be sure that debits stay on the left and credits stay on the right. Such an interest differs not one whit from that of the public generally and fails to distinguish Empire from the gaggle of the public who may be "interested" (in the same sense that Kansas City Royals baseball fans are "interested" in the outcome of the All Star Game but have no legally cognizable interest in that outcome.

Empire's Response demonstrates no customer interest and no potential aggrievement, direct or indirect, in this proceeding. By silence it concedes that it neither operates in Aquila's steam service area, operates its own steam system, nor takes

steam service from Aquila. It does not compete with Aquila for steam customers in any locale in this state. Empire's attempt to interfere in this steam rate proceeding should be rejected.
