JOINT NOTICE

COMES NOW Kansas City Power & Light Company (“KCP&L”), KCP&L Greater Missouri Operations Company (“GMO”) (collectively, the “Company”), and the Staff (“Staff”) of the Missouri Public Service Commission (“Commission”), for their *Joint Notice*, state as follows:

1. Pursuant to paragraph 14 of the Commission Approved *Stipulation and Agreement Regarding Extension of MEEIA 2 Programs During Pendency of MEEIA 3 Case* the Company and Staff notify the Commission that they have agreed on the total avoided cost of capacity prices to be used for program screening and cost effectiveness testing for MEEIA Cycle 3. This total avoided cost of capacity price has been shared with all parties.

2. Further negotiations will continue using the Staff and Company’s avoided cost so that MEEIA 3 programs and budget levels can be finalized in a MEEIA 3 Stipulation and Agreement.
