NOTICE OF EXPIRATION OF VIDEO SERVICE AUTHORITY

Issue Date: December 9, 2022

On December 9, 2022, S-GO Video notified the Commission that it has no customers, has ceased to provide video service, and seeks to cancel its Video Service Authority. The Commission granted S-GO Leasing Company d/b/a S-GO Video that authority in File No. KA-2008-0128, to serve the City of Lanagan, the Community of Racine, the City of Southwest City, the Community of Tiff City, Newton County, and McDonald County.

Under Section 67.2685, RSMo 2016, S-GO's service authorization expired upon notice to the Commission that it will cease to provide video service under that authorization. The Commission acknowledges receipt of notice by S-GO that it has ceased to provide video service. The authorization has expired by operation of law and no further action by the Commission is required. This file may be closed.
