ORDER SUSPENDING TARIFF, DIRECTING NOTICE, AND SETTING INTERVENTION DATE

On May 15, 2009, Union Electric Company, d/b/a AmerenUE, filed a petition with the Missouri Public Service Commission to change its Infrastructure System Replacement Surcharge (ISRS) rate schedule to reflect ISRS-eligible infrastructure system replacements made during the period from June 1, 2008, through March 31, 2009. Section 393.1015.2(3), RSMo Supp. 2008, requires that the Commission act on AmerenUE's application no later than 120 days after it was filed. Consequently, the Commission must issue a decision regarding AmerenUE's petition effective no later than September 12, 2009.

With its application, AmerenUE filed a tariff that would implement the surcharge effective June 14, 2009. The Commission will suspend that tariff until September 12, 2009, to allow sufficient time to review AmerenUE's ISRS application.

Section 393.1015.1(2) requires the Commission to publish notice of AmerenUE's filing. Therefore, the Commission will give notice of this application to the public and to others who may be interested. The Commission will also set a date for the filing of intervention requests.

THE COMMISSION ORDERS THAT:

1. The tariff sheet filed by Union Electric Company, d/b/a AmerenUE, on May 15, 2009, and assigned Tariff File No. JG-2009-0813, is suspended until September 12, 2009, unless otherwise ordered by the Commission. The tariff sheet suspended is:

2. The Data Center of the Missouri Public Service Commission shall mail a copy of this notice to the County Commission for each of the counties in the service area of Union Electric Company, d/b/a AmerenUE, as well as to the corresponding governing body for the City of St. Louis. In addition, the Data Center shall mail a copy of this notice to each party in GR-2007-0003, AmerenUE's last general rate case.

3. The Information Officer of the Missouri Public Service Commission shall make notice of this order available to the media serving AmerenUE's service area and to the members of the General Assembly representing AmerenUE's service area.

4. Any person wishing to intervene in this matter shall file an application to do so no later than June 8, 2009. Such application shall be filed with:
