### MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

**COMES NOW** Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to cancel the certificate of service authority of CLEC, Inc. ("CLEC"). For its Motion, Staff states as follows:

1. On March 10, 2006, the Commission granted CLEC a certificate of service authority to provide basic local telecommunications services, non-switched local exchange telecommunications services restricted to dedicated private line services, and interexchange telecommunications services in the state of Missouri in Case No. LA-2006-0274.

2. In January 2013, Staff received CLEC's Statement of Revenue for calendar year 2012, in which CLEC states it no longer wishes to retain its certificate of service authority. (See Highly Confidential Attachment A).

3. Because CLEC requested cancellation of its certificate and it is not providing services in Missouri to the best of Staff's knowledge, information and belief, Staff recommends that the Commission cancel the certificate.

4. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo 2000, which provides "Any certificate of

service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

5. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission,* 776 S.W.2d 494 (Mo. App. W.D. 1989).

6. CLEC is current on payment of fiscal year assessments and submission of annual reports.

WHEREFORE, Staff recommends that the Commission cancel the certificate of service authority of CLEC, Inc., to provide basic local telecommunications services, non-switched local exchange telecommunications services restricted to dedicated private line services, and interexchange telecommunications services in the state of Missouri.
