ORDER CANCELING CERTIFICATE

Issue Date: August 1, 2012 Effective Date: August 11, 2012

On July 17, 2012, the Staff of the Missouri Public Service Commission filed a motion requesting US Cable Telecom of Missouri, LLC ("US Cable") certificates of service authority to provide basic local telecommunication services and interexchange and local exchange telecommunications services in the State of Missouri be cancelled.

In File Number LA-2007-0453, the Commission granted US Cable certificates of service authority to provide basic local, and interexchange and local exchange telecommunication service in the State of Missouri.

Staff states in its motion that US Cable filed its Statement of Revenue for calendar year 2011, which indicated that the company no longer wishes to retain its operating certificates. US Cable is not deficient in the filing of the Company's annual report and is current on the payment of its fiscal year assessments. Staff recommends that the Commission cancel the company's certificates of service

authority to provide basic local and interexchange and local exchange telecommunications services.

On July 18, 2012, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than July 30, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificates of service authority granted to US Cable Telecom of Missouri, LLC, shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide interexchange and local exchange telecommunications services granted to US Cable Telecom of Missouri, LLC, in File Number LA-2007-0453, is canceled.
- The certificate of authority to provide basic local telecommunications services granted to US Cable Telecom of Missouri, LLC, in File Number LA-2007-0453, is canceled.
 - 3. This order shall become effective on August 11, 2012.

4. This case may be closed on August 12, 2012.
