The original and two (2) copies of this letter is filed as official notification that LDMI Telecommunications, Inc. is changing the name under which it provides telecommunications services in Missouri to LDMI Telecommunications, Inc. d/b/a Cavalier Telephone and d/b/a Cavalier Business Communications. The Company will provide traditional residential telecommunications services under the Cavalier Telephone name and traditional business telecommunications services under the Cavalier Business Communications name. Included with this filing are the Registrations of Fictitious Name filed with the Office of the Secretary of State of Missouri. Customers have been notified of the name change.

The following replacement tariffs are being filed to reflect the name change:
