In fact, the interruptible sales customers' PGA factors will remain unchanged.¹ This order corrects the Commission's June 28, 2017 Order Approving PGA Tariff *nunc pro tunc* to reflect the Commission's intent that the interruptible sales customer's PGA factors will remain unchanged.

¹ The PGA factor for the interruptible sales customers, excluding the Rolla system, will remain unchanged at 33.64¢/Ccf. The PGA factor for the Rolla system interruptible sales customers will remain unchanged at 34.89¢/Ccf.
