On September 29, 2017, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities filed tariffs that would implement a general rate increase for its natural gas service. The Midwest Energy Consumers Group (MECG) applied to intervene on October 2. More than ten days have passed since that application to intervene was filed and no one has responded to the application.

The Commission finds that allowing MECG to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The Application to Intervene of the Midwest Energy Consumers Group is granted.

2. This order shall be effective when issued.
