**ORDER DIRECTING EXPEDITED
STAFF RECOMMENDATION**

On November 3, 2017, The Empire District Gas Company filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment clause and Actual Cost Adjustment and Refund Factor. On November 6, 2017, a substitute cover letter was filed to correct the tariff effective date. The tariff sheets bear an effective date of December 1, 2017.

In consideration of the effective date of the tariff sheets, the Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than November 14, 2017, the Staff of the Missouri Public Service Commission shall file a recommendation with regard to the tariff sheets filed by The Empire District Gas Company in Tariff File No. YG-2018-0055.
2. Any other entity wanting to comment on the tariff sheets or Staff's recommendation shall do so no later than November 17, 2017.

3. This order shall be effective when issued.
