#### STAFF REPORT REGARDING COMPLIANCE TARIFF SHEETS

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Staff Report Regarding Compliance Tariff Sheets* ("Report") states as follows:

On August 16, 2019, the Commission issued its *Order To File Conforming Tariff* ("Order"), effective the same day, directing Ameren Missouri to file tariffs in compliance with the terms of the stipulations and agreements no later than August 16<sup>th</sup> at 5:00pm. The Order also directed Staff to review Ameren Missouri's August 16<sup>th</sup> tariff filing and to file a report regarding the compliance of Ameren Missouri's tariff sheets no later than August 19<sup>th</sup> at 5:00pm.

Ameren Missouri filed its tariff revision, Tariff File No. YG-2020-0032, late afternoon of August 16<sup>th</sup>, allowing Staff to begin its review of the Company's tariff sheets. As a result of Staff's review of the filed tariff sheets, Ameren Missouri filed several substitute tariff sheets on August 19<sup>th</sup>.

As the result of Staff's review of the tariff sheets filed on August 16th, as substituted on August 19th, in Tariff File No. YG-2020-0032, Staff reports that the following tariff sheets are in conformance with the stipulations and agreements filed by the signatories on July 22<sup>nd</sup> (First Amended Nonunanimous Stipulation and Agreement) and July 24<sup>th</sup> (Non-Unanimous Stipulation and Agreement as to MSBA Issues):
