NOTICE OF CHANGE APPLICATION

COMES NOW Charter Communications Entertainment I, LLC d/b/a Charter Communications, ("Company"), pursuant to § 67.2701 of the Missouri Revised Statutes, and in support of its notice of change application seeking to assign its video service authorization to Spectrum Mid-America, LLC ("Spectrum"), states as follows:

1. The Company and Spectrum have main offices in Missouri located at 941 Charter Commons, Town & Country, 63017.
2. Spectrum currently holds a video service authorization approved by the Public Service Commission. See Case No. KA-2019-0097.
3. The Company seeks to assign to Spectrum its video service authorization to provide video service in the following political subdivisions, which assess the following video service provider fee:



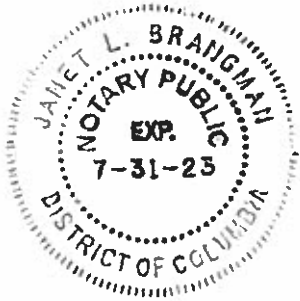
