ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: March 26, 2010 Effective Date: April 5, 2010

On March 4, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting Tele-Reconnect, Inc. ("Tele-Reconnect") certificate of service authority and accompanying tariff to provide basic local telecommunication services in the State of Missouri be cancelled.

In File Number CA-2004-0088, the Commission granted Tele-Reconnect a certificate of service authority to provide basic local telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Tele-Reconnect filed Articles of Dissolution with the Missouri Secretary of State, effective February 1, 2010. On February 4, 2010, the Missouri Secretary of State issued a Certificate of Termination certifying that the corporation has ceased. Staff recommends that the Commission cancel the company's certificate of service authority to provide basic local telecommunications services, and the company's accompanying tariff.

On March 5, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than March 15, 2010. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Tele-Reconnect, Inc., shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide basic lcoal telecommunications services granted to Tele-Reconnect, Inc., in File Number CA-2004-0088, is canceled.
 - 2. Tele-Reconnect, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
 - 3. This order shall become effective on April 5, 2010.

4. This case may be closed on April 6, 2010.
