Local Number Portability (LNP) provides local exchange service customers the ability to (1) retain the same telephone number when changing from one local telephone service provider to another while remaining at the same service location and (2) complete calls to ported telephone numbers regardless of where the call originates.

The LNP End User Charge is designed to recover the charges incurred by the Company related to the provision of long-term number portability. The LNP End User Charge is assessed per residential local exchange service line.

5.11 Network Access Surcharge

The Network Access Surcharge compensates for the Company's cost of installation and maintenance of the components that link the End User location to the telephone network. The Network Access Surcharge is assessed per residential local exchange service line.
