**JOINT MOTION FOR EXTENSION  
FOR FILING RESPONSES TO ORDER DIRECTING FILING**

COMES NOW the Respondent Missouri-American Water Company (“Missouri-American”), by and through the undersigned counsel, and on its behalf and that of the Staff of the Missouri Public Service Commission (“Staff”), respectfully states as follows:

1. On September 25, 2020, Missouri-American filed the *Affidavit of Tracie Figueroa* (“*Affidavit*”).
2. On September 29, 2020, the Commission issued its *Order Directing Filing*, directing Missouri-American to “clarify its previous response regarding its compliance with the 10-year inspection and testing requirement of 20 CSR 4240-10.030(38)” by October 9, 2020. The *Order Directing Filing* also directed Staff to file a report concerning Missouri-American’s *Affidavit* by October 15, 2020.
3. Staff has requested additional discussions with the Company in regard to the Company’s meter change program. Missouri-American believes additional discussions could be helpful in clarifying not only the *Affidavit*, but also Staff’s Report that Staff will ultimately provide to the Commission.

4. Missouri-American and Staff jointly move for a one-week extension for each filing deadline set forth in the *Order Directing Filing*.

5. This motion is not made to burden any party or to unnecessarily delay a resolution in this matter, but in the hope of clarifying the responses that will ultimately be provided to the Commission by both parties.

**WHEREFORE**, Missouri-American moves on its behalf, as well as that of Staff, for the Commission to issue an order granting this Joint Motion for Extension and for the Commission to extend by one week each filing deadline in its *Order Directing Filing*.
