JOINT MOTION TO ESTABLISH PROCEDURAL SCHEDULE

COMES NOW, the Staff of the Missouri Public Service Commission (Staff) and the Office of the Public Counsel (Public Counsel or OPC), as directed by order of the Commission, and respectfully requests that the Commission establish the following proposed procedural schedule in this matter. In support of this request, Staff and OPC state the following:

1. On January 28, 2011, Staff submitted its *Notice of Amended Company/Staff Partial Agreement Regarding Disposition of Small Water Company Revenue Increase Request* (Amended Partial Disposition Agreement). In the Amended Partial Disposition Agreement, Staff and the Company identified payroll, payroll taxes, employee benefits and the effect of these items on income tax as issues it wished to have resolved through arbitration.

2. On February 8, 2011, OPC filed its *Response to Amended Company/Staff Partial Agreement and Request for Local Public Hearing*. OPC stated that it opposed the Amended Company/Staff Partial Agreement and identified issues in support of this position. OPC agreed to participate in arbitration as long as the Commission determined that OPC's issues of depreciation expense and reallocation of deprecation reserve would be included in the list of issues to be arbitrated.

3. Staff has coordinated the following proposed dates with the Rex Deffenderfer Enterprises (RDE or Company).

4. Staff, with the consent of the Company, and OPC propose the following

procedural schedule to proceed to arbitration:

Arbitration (Jefferson City, MO)
