
NOTICE OF CORRECTION

COMES NOW the City of Joplin, by and through counsel, and provides notice to the Commission and the other parties to the case of an error in the City's Application to Intervene, filed on July 18, 2011. For its Notice of Correction, counsel for the City of Joplin states:

1. In Paragraph 3 of its Application to Intervene, counsel stated "Additionally, the proposed tariffs raise rates on Joplin district ratepayers by more than 17%." The statement is wrong.
2. With respect to residential customers, Missouri-American's proposed tariffs would reduce the bill of a residential customer with a 5/8" meter would be reduced from \$35.85 per month to \$35.21 per month. This is consistent with Appendix B to Missouri-American's cover letter and P.S.C MO NO. 13, Original Sheet No. RT 5.
3. The City of Joplin has not analyzed the impact of the proposed rates on any class other than residential.
4. Counsel apologizes to the Commission and to the other parties to the case for any inconvenience caused by its error.


