**RE: Case No. GR-XXXX-XXXX, Missouri Gas Energy**

Attached for filing on behalf of Missouri Gas Energy is an electronic version of P.S.C. MO. No. 1, Twenty-First Revised Sheet No. 24.3, canceling Twentieth Revised Sheet No. 24.3. This tariff sheet bears an issue date of June 23, 2010, and a proposed effective date of July 8, 2010.

By this filing, MGE proposes to make an adjustment to the Purchased Gas Adjustment (PGA) Rate as permitted under the provisions of Sheet No. 15 of MGE's tariff. MGE is proposing to adjust the Current Cost of Gas Factor (C.C.G.).

The proposed PGA Rate of \$.82433 reflects an increase of \$.12679 per Ccf over the PGA Rate currently in effect of \$.69754. The change in the PGA Rate reflects an increase in the C.C.G. Factor of \$.12679 per Ccf, from the current C.C.G Factor of \$.68937 to the proposed amount of \$.81616.

The proposed adjustment has the overall net effect of increasing revenues in MGE's service area by approximately \$71,138,160 annually. This represents an overall 18.18% increase in revenues.

Workpapers supporting the calculations performed in developing the proposed changes have been provided this date under a separate cover letter to the Commission's Staff and The Office of the Public Counsel.
