- B) Please see attached nominations regarding the quantity of each nomination, the date the nomination applied to, the contract number that the nomination applied to, and receipt and delivery points for the nomination.
- C) The rationale for why each nomination was made in terms of the quantity, date, and location was to satisfy forecasted load requirements for each area via gas purchases and/or storage nominations. The contracts pertaining to each area are: Hannibal – contract numbers 11671, 11598, and 14089; Bowling Green – contract number 11474; Butler – contract number 11867.
