SUBJECT: Staff Recommendation on Southern Missouri Gas Company, L.P.'s Optional PGA Filing

Effective July 1, 2008

DATE: June 11, 2008

On June 3, 2008, Southern Missouri Natural Gas Company, L.P. (SMNG or Company) d/b/a Southern Missouri Natural Gas Company of Mountain Grove, Missouri, filed a tariff sheet with a proposed effective date of July 1, 2008. The tariff sheet was filed to reflect changes in SMNG's Purchased Gas Adjustment (PGA) and factors as the result of estimated changes in the cost of natural gas for the summer season. The summer season includes the months of April through October.

The net effect of this change will increase the Total PGA factor to \$1.3630 per hundred cubic feet (Ccf) for the summer season (April – October) from the Total PGA factor of \$0.972 per Ccf currently in effect. This represents an overall increase of \$0.3910 per Ccf.

Case No. GR-2008-0379, under which this change was filed, was established to track the Company's PGA factors to be reviewed in its 2007-2008 Actual Cost Adjustment (ACA) filing. Case No. GR-2007-0484 was established to track the SMNG's PGA factors to be reviewed in its 2006-2007 ACA filing. Interim subject to refund status should be maintained pending final Commission decisions in Case Nos GR-2007-0484 and GR-2008-0379.

The Energy Department – Tariffs/Rate Design Staff (Staff) has verified that the Company has filed its annual report and is not delinquent on any assessment. Staff has reviewed this filing and is not aware of any issue currently pending before the Commission that affects or is affected by this filing.

Staff has determined that the rates on the proposed tariff sheet were calculated in conformance with SMNG's PGA Clause. Staff is of the opinion that good cause for approval of SMNG's tariff sheet on less than thirty (30) days notice is demonstrated by SMNG's Commission-approved PGA Clause allowing for

ten (10) business days notice for PGA change filings. Therefore, Staff recommends that the following tariff sheet filed on June 3, 2008, is in compliance with SMNG's tariff and should be approved interim subject to refund:
