STAFF'S RESPONSE TO ORDER DIRECTING FILING

COMES NOW the Staff of the Missouri Public Service Commission and for its response states:

1. On September 21, 2005, the Commission directed the Staff to file a verified supplemental pleading stating, for each wireless or commercial mobile radio service company that Spectra Communications Group, LLC d/b/a CenturyTel lists in its application or testimony as a competitor, whether or not a call from a Spectra Basic Local service subscriber in that exchange to a subscriber of the CMRS carrier resident in the same exchange would be rated and billed as a local call.

2. The requested information is provided in the attached Verification labeled Appendix A.

3. The Commission initially requested that this pleading be filed on or before 5:00 p.m. on September 22, 2005. However, the Commission subsequently reset the hearing in this case and the Regulatory Law Judge assigned to this matter indicated that the parties were granted an additional day to make the filings that were due on September 22, 2005.

WHEREFORE, the Staff requests the Commission to accept Staff's Memorandum.





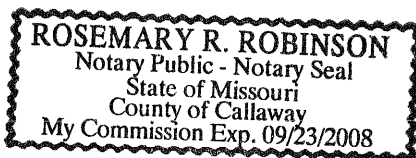

³ "No" indicates none of the wireless providers identified by the company have a block of telephone numbers to assign customers within the exchange; nor does the exchange have toll-free calling to another exchange where the wireless provider may have local numbers which can be dialed on a toll-free basis by all customers within the exchange.

⁴ The "Other" column describes situations where the wireless provider does not have local numbers within this particular exchange but the wireless provider does have telephone numbers in another exchange which may have some form of toll-free calling between the exchanges so that callers in the exchange can dial subscribers to the designated wireless provider on a toll-free basis.
