#### **RE:** tw telecom of kansas city llc- Notification of Name Change

Dear Mr. Woodruff:

This filing is submitted on behalf of **tw telecom of kansas city llc** (the "Company") to notify the Commission that it has changed its name to Level 3 Telecom of Kansas City, LLC. The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company's name as "Level 3 Telecom of Kansas City, LLC." The Company is authorized to provide local exchange and interexchange services in Missouri pursuant to authority granted in Case No. CN-2008-0363, dated June 18, 2008.

A copy of the Company's name change filing with the Missouri Secretary of State is attached hereto as <u>Exhibit</u> <u>A</u>. An Adoption Notice for the Company's Access Services P.S.C. MO Access Tariff No. 12 is attached hereto as <u>Exhibit B</u>. The Company detariffed their local and interexchange tariffs via their February 12, 2016 letter to the Commission. Once the Commission has approved the name change the posted local and interexchange price lists will be updated to reflect the new name as well as a replacement access tariff will be filed with the Commission.

The Company provides service to business customers only and has changed its name to better align with their parent company, Level 3 Communications, LLC, under a unified brand and it will not affect any services or rates provided to customers of the Company. The following statement appeared on the invoices of all tw telecom customers in the March bill cycle: "Effective February 1, 2016, tw telecom holdings, llc and its subsidiaries have changed their name to Level 3 Telecom." The Company requests an effective date of June 26, 2016 for this filing.


