MOTION FOR CLARIFICATION

COMES NOW Western Communications, Inc. ("Western" or "Applicant") pursuant to 4 CSR 240-2.160 and for its Motion for Clarification states to the Commission as follows:

- 1. Applicant has herein filed an Application for Certificates of Service Authority to Provide Basic Local, Local Exchange, Exchange Access and Interexchange Telecommunications Services and for Competitive Classification to operate under the name Logix Communications (in connection with Case No. LM-2003-0028 under which Applicant seeks authority to transfer the assets and subscribers of Logix). Applicant has also filed notice of the adoption of the Logix tariffs with the Commission and informed the Commission of the assignment of the previously approved Logix/SWBT interconnection agreement.
- 2. On September 24, 2002 the Commission issued its Order Granting Certificates.
 - 3. Applicant seeks clarification of the Commission's Order as follows:
- a. Add an express acknowledgment that Applicant will be providing telecommunications services in Missouri under the name Logix Communications.

- b. Clarify that Ordered item 1 includes exchange access service and full local exchange authority within the identified exchanges.
 - c. Clarify that Ordered items 2 and 3 provide for statewide authority.
- d. Delete Ordered item 9. This language concerns applications for authority under Section 392.451 (small ILEC exchanges) and is not applicable to Applicant.
- e. Clarify that Applicant has filed notice of assignment of a previously approved interconnection agreement and notice of tariff adoptions, and that said tariff adoptions are approved to be effective no later than October 4, 2002.
- 4. As reflected in Applicant's Second Motion for Expedited Relief, action is requested before October 4, 2002.

WHEREFORE, Applicant respectfully requests the Commission to clarify its Order as stated herein and Applicant's Second Motion for Expedited Relief before October 4, 2002.
