I, Daniel Lloyd, a natural person, do hereby swear and affirm that I am an officer of inContact of Missouri, Inc. ("Applicant"), and that the following statements are true and correct to the best of my knowledge and belief:

(1) The location of the principal place of business and the names of the principal executive officers of Applicant:

- (2) That Applicant will offer interconnected voice over Internet protocol service in every telephone exchange within Missouri;
- (3) That Applicant is legally, financially, and technically qualified to provide interconnected voice over Internet protocol services;
- (4) That Applicant is ready, willing, able, and will comply with all applicable state and federal laws and regulations imposed upon providers of interconnected voice over Internet protocol services;
- (5) That Applicant will charge and collect from its end-user customers on interconnected voice over Internet protocol service, and remit to the appropriate authority, fees and surcharges in the same manner as are charged and collected upon end-user customers of local exchange telecommunications service and

remitted by local exchange telecommunications companies, including but not necessarily limited to:

- (a) Telecommunications programs under section 209.255, RSMo;
- (b) Missouri universal service fund under section 392.248;
- (c) Local enhanced 911;
- (d) Any applicable license tax;
- (6) That Applicant will remit the annual assessment imposed by the Commission under section 386.370, RSMo;
- (7) That Applicant will file, either directly or indirectly through an affiliated competitive local exchange carrier, with the Commission an annual report at a time and covering the yearly period fixed by the Commission;
- (8) That Applicant has established a process for handling inquiries from customers concerning billing issues, service issues, and other consumer-related complaints. Consumer complaints may be directed to: Applicant's Customer Care Department at (801) 320-3200 or via e-mail to CustomerCare-CustomerService-General@incontact.com; and,
- (9) Applicant's interconnected voice over Internet protocol service meets the following criteria:
 - (a) Enables real-time, two-way voice communications;
 - (b) Requires a broadband connection from the user's location;
 - (c) Requires Internet protocol-compatible customer premises equipment; and

(d) Permits users generally to receive calls that originate on the public switched telephone network and to terminate calls to the public switched telephone network.


